St. Joseph Medical Center — Matter No. 18-03-2415; New construction and renovations to the hospital for the replacement and consolidation of the current perioperative services facility (operating rooms, cardiac catheterization labs, electrophysiology and interventional radiology labs), sterile processing and support areas; Estimated Project Cost: \$60,000,000.
