Add'l. Info: The Secretary of the Maryland Department of Natural Resources, pursuant to Code of Maryland Regulation (COMAR) 08.02.05.17A and C, announces the season, catch limit, and minimum size for the recreational cobia fishery for 2018. Effective 12:01 a.m. April 6, 2018:

- The season is open June 1 through September 30, 2018. It is closed all other dates.
- Recreational anglers may keep 1 cobia per person per day; or Up to 3 cobia per vessel per day if there are 3 or more individuals on the vessel.

- The recreational minimum size for cobia is 40 inches total length.

Subject: Public Notice — 2018 Female Blue Crab Importation Dates

Add'l. Info: The Secretary of the Maryland Department of Natural Resources, in consultation with blue crab advisory groups, pursuant to the Code of Maryland Regulations (COMAR) 08.02.03.08C, announces that female crabs from which the egg pouch or bunion has been removed, or egg-bearing female crabs known as sponge crabs, may be imported into Maryland from another state by a dealer or crab processing plant only during the period May 11, 2018 through July 20, 2018. Dealers and crab processing plants must have a bill of sale or lading from the jurisdiction of origin and may not import the crabs at any other time of the year.
